Pursuant to your request and in compliance with Indiana Code 5-14-3, the information of which you have requested is contained below:

The Martin County Community Corrections Advisory Board acts/serves as the local JRAC for Martin County as well. The board voted to serve dual roles following Governor Holcomb's institution of the local JRACs as many of the statutory members of the community corrections advisory board overlapped with that of the statutory members of the local JRAC.

The board(s) meet on a quarterly basis for regularly scheduled meetings, with exceptions to any advertised special and/or executive sessions throughout the year. The current schedule of meetings for 2024 is:

- Thursday, March 7th, 2024
- Thursday, June 6th, 2024
- Thursday, September 5th, 2024
- Thursday, November 7th, 2024

* A copy of the membership list is attached to this email for your reference. Please be advised, Loogootee Municipal elections were held in 2023 and the Mayoral election will affect the updating of this list at the March 7th meeting as Noel Harty is no longer the Mayor and member of the board. Effective January 1, 2024, Mayor Brian Ader will fulfill that statutory spot and his information will be updated at the meeting on March 7th, 2024.
