1. Call To Order

Judge King called the meeting to order at 12:15 p.m.

2. Old Business

Director Schmaltz reviewed the Levels of Supervision Programs (Home Detention, Day Reporting, CADS Program, Adult/Juvenile MRT, Community Service). Director Schmaltz made the Board aware the CADS Programs is at capacity, without anyone on the waiting list, and the referrals have remained consistent with MRT, Home Detention, Day Reporting and Community Service.

3. Director Schmaltz reviewed the Project Income Financial Report and the Project Income Collection Rates with the Board. Director Schmaltz reported as of November 30, 2023, the Project Income Cash Balance was \$297,614.00. Director Schmaltz advised of the following 2023 cumulative average collection rates: Home Detention is 98%; Day Reporting is 101%.

4. New Business (Community Corrections)

5. Director Schmaltz advised the Board Dr. Harrison's last day with Margaret Mary Health was November 28, 2023. Dr. Harrison served as the clinical supervisor of the CADS Program since the inception of the program and he has been the acting therapist for the previous two and half years. Director Schmaltz explained MMH does not plan to replace the CADS therapist to facilitate the group but will continue providing the CADS assessments, with expedited priority. Director Schmaltz advised Court Services paid MMH \$30,000.00 per year for the previous four years from the Indiana Office of Court Services SIM Grant to help supplement the CADS therapeutic services. Director Schmaltz stated the SIMM grant funding, however, ended in September 2023. Director Schmaltz advised going forward, unless an organization can be secured with Medicaid and/or Recovery Works billing, the CADS Program therapist most likely will be paid as a contractual service. Director Schmaltz explained there has been a lack of response received from several attempts made to replace the CADS therapist. Judge King

recommended Director Schmaltz continue seeking a response for treatment services from St. Elizabeth Behavioral Healthcare.

6. Ty Robbins, IDOC/Community Corrections Program Director, was an observant of the meeting. Program Director Robbins stated he met with Director Schmaltz today and updated the Board Members with feedback from the CPC-CSA assessment of Ripley County Court Services' programs and services conducted on July 26, 2022. Program Director Robbins recommended, considering the financial dilemma to replace the CADS therapist, the Board may want to consider requesting grant funding for the CADS therapist from the 2025 IDOC Probation Grant.

7. New Business (Local JRAC)

Sheriff Bradley discussed the progress of the Ripley County Jail Programs Room. Sheriff Bradley stated Director Schmaltz and he attended a grant review meeting last month with Rising Sun Regional Foundation for funding the project. Additionally, Sheriff Bradley reported Directed Schmaltz is awaiting on a grant application reply from Ripley Community Foundation for additional funding of the Programs Room as well. Ty Robbins, IDOC/Community Corrections, advised Sheriff Bradley can contact Jack Hendricks, IDOC, for questions regarding GED and time-cuts. Mark Horstman stated if grant funding is not received to furnish the Programs Room, Sheriff Bradley should request financial support from the Ripley County Commissioners.

8. Rob Moorhead made a motion to adjourn. Dana Row made a second motion. The meeting was adjourned at 12:51 p.m.
